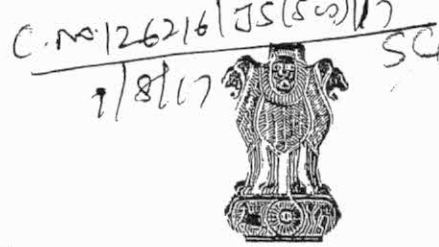



### Organisers

"United India Chamber Of Commerce & Industry", New Delhi are the organisers of "World Expo 2017".

### Venue, Dates & Timing

"World Expo 2017" will be held at Expo Centre, Sector 62, Noida from August 26 - 27, 2017. Visitors will be allowed from 11 am to 09pm on the show.

### Participation Charges

**RAW SPACE PACKAGE:** Only raw space would be provided to the exhibitors @ Rs 7,000/sq mtr.

**SHELL SCHEME PACKAGE** – Ready to use booth without display materials Shell stand will include three sides partition, fascia name, floor carpet, Three spotlights, one 5/15 AMP socket, one trash bin, one reception desk and two chairs per 9 sq. meters. (Rs 10,000/ sq mtr.)

Services Tax @ 15% on net participation charges 1 sq. meter = 10.7639 sq. feet

### Participation Payment Terms

- Application for participation has to be submitted to UICCI along with 100% of total participation charges by August 05, 2017.
- Participation will be accepted on first-come, first-served basis
- Participation fee once paid will not be refundable. All payments will be made through bank transfer. Or Via Cheque in favor of "UNITED INDIA CHAMBER OF COMMERCE & INDUSTRY"

### Allocation of Space

Due consideration will be given to the choice and requirement of the allocation for the Raw Space/Stand. However, UICCI reserves the right to allocate/reallocate space, change the layout, add or delete corridors which may affect the orientation of stalls. Its decision in this regard shall be final and binding.

### GST Tax

Govt. of India has levied GST on all exhibition services. This tax is applicable on the stall rentals, electrical charges and other fair services for the exhibition. The service tax including surcharges payable on the captioned fair will be 18% on the billing amount.

**Electricity & Power Connection and Consumption** Each shell stand will be provided with three spot lights and a 5/15 AMP socket per 9 sq. mtrs. For this facility the exhibitors will not be charged extra upto a max. load of 1 Kw for 9/12 sq. mtrs stand. Those who require additional power will have to pay Rs 5000/- per kw plus taxes, as applicable, for 2 days. Exhibitors opting for bare space have to pay for electricity/power connection and consumption as per the rates applicable.

### Possession of Space

Possession to exhibitors taking bare space will be given after 03.00 p.m. on August 25, 2017. For exhibitors under shell scheme, possession will be given after 4.00 p.m. on August 25, 2017. The handing over of possession in both cases will be subject to final payment of participation charges, catalogue entry fee, electricity charges etc. to UICCI.

### Construction of Stands

The interior design of the stand will have to be within the architectural controls laid down by UICCI and design of the stand will have to be approved from UICCI before July 25, 2017. Exhibitors who do not comply with these guidelines and regulations will have to pay a penalty of INR 10000/- and will run the risk of closure of the stand by UICCI. All construction material, waste and empties etc. will be removed by 10 p.m. on 25 August, 2017. Work regarding construction of stands will be permitted within the stand area only or outside the hall and in no case in the walkways in the halls.

### Stand Completion

UICCI will not be responsible for the turnout of buyers/buying agents for any Exhibition/fair/show/BSM etc. UICCI will have no liability whatsoever for any kind of refund or payment in this regard.

### Stand Completion

Stands will be completed by 10 pm on August 25, 2017.

### Operation of Stands

No stand will remain unattended. All stands must open at least half an hour before the exhibition and shall remain open till half an hour after the exhibition time on each day. No activity, which, in the opinion of the UICCI, amounts to nuisance or annoyance, will be caused by the participants.

### Storage of Exhibits & Empties

No exhibits or empties will be stored behind the exhibition stands.

### Vacation of Space

Stands will have to be vacated under shell scheme and bare space latest by 01 p.m. on August 28, 2017.

### Damages to the Hall

It is not permitted to affix coverings by bonding or to paint hall walls, pillars or any other parts of the hall. Drilling or shooting-in of bolts, as well as hammering of steel nails, dowel, etc. into floor, pillars & panels is not permitted. The cost of damage caused by the exhibitor, its employees, representatives or agents to the exhibition hall will be billed, to and paid for, by the exhibitor before the closing of the exhibition.

### Fire Safety

Fire safety rules and regulations will be observed at all times. It is not permitted to store or use inflammable liquids/packaging material or any other such material in the hall.

### Security

Participants will be responsible for the security of their exhibits and stalls. UICCI will, however, make general security arrangements at the exhibition halls. The participants will be participating in the fair at their own risk and cost.

### Handling of Exhibits, Customs and Import

Exhibitors can avail the services of the cargo agents empanelled by UICCI. No other cargo agent will be allowed to enter/operate in the exhibition.

### Service Agencies

Service agencies like security, cleaning, phones, catering, courier etc. empanelled with UICCI will only be allowed to provide services to the exhibitors. Other agencies will not be allowed to enter/operate in the exhibition.

### Insurance

Against all ascertainable risks from transportation to display and removal should be done by exhibitor. UICCI will not be responsible for any claim.

### Entry/Exit

Entry into Great India Celebration will be on the basis of exhibitor passes issued by UICCI. Each exhibitor will be entitled to 2 passes per 12 sq. mtrs & 1 pass per 9sq mtr space. Entry of vehicles in Expo Centre will be permitted during exhibition hours and other hours specified separately. Exit passes will be necessary for exhibits/ material to be taken out of Great India Celebrations.

### Violation of Rules

In the event of violation of any rules, UICCI will have the right to close down the stall of the exhibitor.

### Disputes

Disputes, if any, arising out of unresolved matters between exhibitor and UICCI shall be settled by arbitration in accordance with the Arbitration and Conciliation Act 1996. The arbitration proceedings will be conducted in English and at New Delhi, India only. All disputes are subject to Delhi Jurisdiction only.

### Force Majeure

If the exhibition is abandoned, cancelled or suspended in whole, or in part, by reasons of war, fire, national emergency, labour, terrorist activity, no availability of exhibition premises or any other cause, not within the control of UICCI, UICCI may, at its own discretion, adjust the rental paid by the exhibitor in the next event or any of its upcoming event. The adjustment of the retail paid by the exhibitor would be done after deducting the expenses incurred on the event, or a part thereof, but UICCI shall be under no obligation to refund any such rental, and part thereof, and shall be under no liability for any actions, claims or losses UICCI reserves the right to cancel/reschedule the fair or change its venue at any point of time or revise visiting hours for any reasons. No claim whatsoever shall be entertained from any Exhibitor/Visitor on this account.
