AEPC is participating in “International Apparel and Textile Fair”, Dubai, UAE to be held from 27<sup>th</sup> to 29<sup>th</sup> November, 2023, which will take place in World Trade Centre, Dubai, UAE.

**1. About IATF:**

International Apparel and Textile Fair (IATF) is UAE’s premier platform for sourcing Apparel, Fashion Fabrics, Prints, Machineries, Clothing Accessories, Home Textiles, Footwear and Handbags. IATF in its 16th edition will be showcasing Spring-Summer collections & Autumn-Winter highlights. The fair attracts a wide range of textile mills, accessories / trim suppliers, print designers, and major footwear manufacturers. Exhibitors are mainly from Europe, India, China, Indonesia, Japan, Turkey, and various highly renowned manufacturing countries across the globe. India’s total export of RMG to UAE has been stable in the last five years India captured a share of 12.62% in 2021.

The United Arab Emirates is now becoming the world’s leading center for textile industry automation with the presence of about 200 apparel manufacturing companies. Accounting for about 5.5 percent of the world’s annual textile and clothing sales, the UAE has today become the world’s fourth largest trading center of fashion and apparel. The Gulf countries are gradually becoming the world’s leading textile manufacturing and trading centers due to good economic environment and fair trade practices, according to a recent international report.

IATF provides manufacturers and their agents an opportunity to showcase their products to the most influential buyers and designers in the Middle East & North Africa (MENA) Fashion sphere. Principally a “Trade Only” event, IATF provides a professional and conducive atmosphere for business and networking.

**4. Avail benefit in participation fee on account of MAI grant from Ministry of Commerce:**

**NOTE: The proposal has been submitted to the Ministry of Commerce, Govt. of India for MAI Grant and following is subject to the receipt of approval / sanction of Grant.**

**Eligibility for financial assistance under Market Access Initiative (MAI) scheme:** As per Notification no. K-11020/9/2021-E&MDA dated 19th July, 2021 of Ministry of Commerce & Industry, Department of Commerce (E&MDA) Division reg. eligibility for availing MAI grant with following conditions:

“a maximum of three participations in a particular trade fair/ exhibition would only be eligible for MAI assistance, i.e. members who have availed assistance three times (including past cases) for a particular fair / exhibition thereafter have to participate in that fair on their own. Further MAI funding support shall only be provided to a member for a maximum of three MAI events in a year. In case of exporter belonging to SC/ST/Women and the exporter is having FOB Value of exports less than Rs. 50 crore in a year, 5 participations in a particular event is allowed.”

**Reimbursement of airfare:-** Further, the Council would propose to Dept. of Commerce for sanction of grant on account of reimbursement of airfare (economy class) if it is approved by Ministry of Commerce, Govt. of India. accordingly, regular director / partner / proprietor / regular officer of the company on senior managerial position of participating firm/co., having 12 months membership with Council, exporter having FOB less than Rs. 50 Cr. in the preceding year shall be eligible for reimbursement of airfare as per MAI guidelines under para 6 (ii) of the Market Access Initiative Scheme 2021 issued by the Ministry of Commerce from time to time. **Non-MAI Exhibitor shall not be eligible for reimbursement.**

**5. Participation Charges: The participation charges does not include air-fare, hotel expenditure or any other kind of personal expenses (logistics etc.): The below subsidized participation fee is based on the anticipated grant from the Ministry. In case of any variation the participation fee may be revised.**

**8. Booth Packages:**

The following booth facilities shall be provided to the participating exhibitors.

- 9 Sq.Mtr. booth includes – 1 table, 2 chairs, 3 spotlights, 4 dozen hangers, One hanger rail stand, Carpet, Name Fascia, Power Socket, Waste bin, Catalogue Entry, Complimentary water for every AEPC exhibitor (6 bottles of 1.5 ltr each) for the duration of the show etc.

**9. Guidelines for allotment of the booths:**

1. All participants who have paid the full participation fee on time would be considered for allotment of booths through draw of lot.

2. No change in the booths, once allotted would be entertained under any circumstances.
3. The decision of Chairman-EP (AEPC) / Chairman (AEPC) would be final and binding in case of any dispute.
4. The participation is on **FIRST-CUM-FIRST SERVED (FCFS)** till all booths are sold and the allotment of stalls shall be done through draw of lot basis.

#### **10. Waitlist:**

In case, applications are over-subscribed, a waitlist will be maintained, which would be considered on FCFS basis. Applicants are advised to ensure that they possess will obtain necessary visa to enter UAE. No request for refund will be entertained by AEPC if for any reason whatsoever visa is not granted.

#### **11. Cancellation charges:**

Terms & conditions for withdrawal will be as follows:

- Rs. 25,000/- + GST charges will be forfeited if the exporter withdraws before the Draw of Lot.
- 100% forfeiture after Draw of Lot.
